Never Leave a Child or Animal Unattended in a Vehicle

Florida law prohibits leaving a child unattended in a vehicle (FSS - 316.6135)

- Neglect of a child (without injury) FSS 827.03(3) is a 3rd degree felony punishable up to 5 years in prison
- Neglect of a child (with injury) FSS 827.03(3)(b) is a 2nd degree felony punishable up to 15 years in prison
- Aggravated Manslaughter of a child (death) FSS 782.07(3) is a 1st degree felony punishable up to life in prison

Members of the community can be fined up to \$500 for leaving an animal unattended in a motor vehicle.

Palm Beach County Ordinance 98-22 Sub Section 24

(h) - It shall be unlawful for any person to leave an animal in any unattended motor vehicle or transport an animal in any motor vehicle without adequate ventilation, sanitary conditions, or otherwise under such circumstance as to prevent the animal from being subjected to extreme temperatures which adversely affect its health and safety.

If you see a child or animal left unattended in a vehicle call 911

AFIS: Automated Fingerprint Identification System



AFIS is a fingerprint and criminal history system used to provide investigative leads. A cutting-edge million dollar AFIS Upgrade was installed, validated and implemented in the PBSO Forensic ID Unit. The initial results are impressive and promising.

The new software:


- ⇒ Auto-encodes minutiae on both latent prints and arrest records speeding up the process.
- ⇒ Allows current ten print arrest records from jail bookings to be completely processed by AFIS and without human intervention.
- ⇒ Provides immediate search results from hand-held Biometric devices used by Road Patrol when index fingers are scanned from an individual and a search is launched against Local, FDLE and FBI Fingerprint Data Bases.
 - ⇒ The new advanced system generates identifications from old cases not recognized previously by earlier software.
 - ⇒ The most dramatic effect is the immediate 30% increase in latent print identifications.

Impounding Officer or Forfeiture Authorization is needed for all releases.

Forfeiture Vehicles have an administrator fee of \$350.00 plus the tow fee at the time the vehicle was impounded.

There are no daily storage fees.

All fees must be paid in the form of a Money Order or Cashier's Check as no cash or credit cards are accepted.

- Hospital visitation

- Baptism, dedications

PBSO Health & Wellness Providers and Employees, West Palm Beach Clinic

Palm Beach County Sheriff's Office Health & Wellness Clinics Receive Cigna Champions Award


The PBSO/Cigna Onsite partnership was so successful with this initial Health & Wellness Center that a second center was initiated outside of West Palm Beach. The new site opened in October 2013, in Wellington, and has achieved outstanding results to date. The Wellington center also provides pediatric services to dependent children over age two with its own dedicated staff and providers.

PBSO Health & Wellness Centers are primary care clinics that also provide flu shots, educational "lunch and learn" sessions with the deputies and personnel, and work directly with their leadership team to provide an outstanding health and wellness strategy for all employees.




