



All thanks to an agency-wide email and a selfless act of love.

In 2004, at 24 years old, Jesse Mesa was diagnosed with Lupus, an autoimmune system disease that can affect any organ in the body and may cause a wide range of symptoms. In her case, it targeted her kidneys.

Nine years later, Jesse's kidneys completely failed. It was then that she began to receive dialysis three times a week. This life-saving technique cleans out impurities and excess fluid from the body. Yet, this is usually a temporary solution for patients in need of a kidney transplant.

After a series of hurdles, including having to lose weight, battling thyroid cancer and having to take care of her boyfriend after suffering a heart attack, Jess was finally put on the list to go through a kidney transplant surgery in April of

A month later, and after lots of back-

and-forth, Jesse wrote an email that changed her life forever. In it, she explained to her PBSO family of nearly five thousand employees that her health is deteriorating and she is in need of a kidney transplant.

"I'm not the kind of person to ask for help, it took a lot of me to allow myself to ask for help, but after a lot of support, I did it," explained Jesse, who has been very quiet about her disease. "Everyone has their issues, you can look at somebody and not know what they are going through," she continues.

Within an hour of that email, Amber Savoie, Jesse's coworker, another 911 Dispatcher replied.

Jesse remembers the reply was very nonchalant, not a reply you would expect to receive after someone is asking for a kidney. It was something like: "Hey, I have a kidney, I am "O- Blood type", you want it?"

Amber, who is also a Color Guard Director at a high school in Lantana, submitted herself to a series of tests and ended up being a match. She can not imagine not doing this for Jesse.

Amber believes in being "Someone's sunshine when their skies are gray." She has that phrase tattooed on her back and she lives by that motto.

Yet, Amber wasn't the only one willing to sacrifice an organ to save Jesse's life. Jesse says six selfless people prescreened for the match, but Amber was the only match.

Jesse and Amber became "kidney sisters" on December 12 after undergoing a successful kidney transplant surgery at Cleveland Clinic.

"What a selfless human being, I am eternally and will be eternally grateful to her. She is giving me the gift of life," says Jesse with tears in her eyes. "That's probably the best gift anyone could give somebody."

My Green Family

I come to you with a humbled heart. It has taken me almost a month to muster up the courage to write this letter. I've been persuaded by several people, mainly my better half Detective Clifton Hamilton, an AMAZING success story, my Supervisor Heidi Grob and Deputy Mitchele Shaffer. Some of you may know me personally, others know me by the voice behind the radio, and some may not know me at all. I started working as a Communications Officer for the City of Boca Ration Police Department in 2000. I was recruited by PBSO in 2005 and have been with this amazing department ever since. I couldn't imagine doing anything else. This is what I was born to do.

In early 2004, after months of testing, I was diagnosed with
Systemic Lupus. At age 24 I was given a 5 year life expectancy.
My nineteen year old son was four at the time. My life seemed
to be falling apart. It was a rough diagnosis but I felt I was strong enough to push, and beat the olds.
Luckily as Lupus became easier to diagnose, science took over and with medication and diet, life
expectancy increased. I have lived with Lupus for 15 years, and have the ability to live a full life.

Lupus has been a roller coaster of pain and suffering, with flare ups that are unexplainable. In 2010 I began to notice myself deteriorating, I went to the doctor and was rolld that my Lupus had chosen an organ to attack. It was my kidneys, Luckily at that point they were still working. Unfortunately things took a turn for the worse in fanuary 2014, my kidneys had given up and stopped working. It was at Delray Medical Center, in fanuary of 2014 that I began dialysis treatments and have been on dialysis every Monday, Wednesday, and Friday from 4pm-8pm since, January 2016, I began the process to get on a Kidney Donation list. While doing the testing, cancer was discovered in my thyroid. In May 2016 the cancer was removed. I was now required to be cancer-free for two years before getting on the kidney donation list. My two years was May 2018. I got retested and am cancer-free. This is first time I've been placed on the National Kidney List.

So here is where the hard part comes in. I had a live donor that had been waiting for me since day one. Unfortunately he fell through due to health issues. Though I'm on the deceased donor list. I was hoping for a live donor, as they last twice the amount of time. A deceased donor kidney lasts between

Saved a Life!

While patrolling the beautiful waterways of the Intercoastal, one of Palm Beach County Sheriff's Volunteer Units ended up saving not one, but three lives.

It all began around 1:00 PM when a member of the Volunteer Marine Unit heard a call on the radio from a person who needed immediate help in the water. Without thinking about it twice, the volunteer went to the location and found a woman in the water holding on with one hand to the rented jet ski she had fallen from. She was swallowing water and gasping for air. The volunteer was able to radio the other members of the Volunteer Marine Unit for assistance. The unit was able to retrieve the distressed woman from the water, along with two other individuals. It appeared that the group did not know how to swim.



As the unit approached the shore, Fire Rescue was called. They were able to perform CPR on the women who had already lost consciousness.

Deputy Gives Jeffirey His


FIRST GLASSES

Deputy Gary Flowers was not just a regular sworn deputy, he was special.

In 2018, he was presented with a life-saving award for saving a 67-year-old woman with dementia who had walked away from home and fallen into a lake. Without hesitation, he jumped into the lake and saved her from the unthinkable. If once wasn't enough, he did it again in

2019. This time he saved two people from a car that ended up losing control and sinking in the bottom of a lake. Both Deputy Flowers and Deputy McNab jumped in with no regard for their own safety and saved them.

Yet, this was of no surprise since Deputy Flowers faithfully served our country in the U.S. Marine Corps and the National Guard. After Honorable Service in the military, Gary served and protected the residents of Palm Beach County as a PBSO Deputy assigned to the Traffic Division - Motors Unit. On January 21st, Deputy Flowers passed away leaving his family, friends and his brothers and sisters from The Palm Beach County Sheriff's Office grieving a terrible loss.

Deputy Rouzeau passed away on January 21, 2020. A public viewing was held Saturday, February 1, 2020, at Bethel Church in Palm Springs.



La Fiesta de Pueblo



To file a report online, email to onlinereporting@ pbso.org

Ready to file an online police report?

Make sure you have the following information


- When the incident happened (date and time)
- Where the incident occurred (address, location and name of business)
- Who is reporting this incident (name, date of birth, contact information)
- Who is involved in this incident (name, date of birth, contact information)
- If this report involves property (make, model, serial number, description and estimated value of the property)

What to expect after you file your report

- You will see the words "your report has been submitted". This means that your online report has been received by the Palm Beach County Sheriff's Office online reporting system.
- Your report will automatically be assigned a Temporary Report Number. You will be able to immediately print a copy of the temporary report.
- All submitted reports will be reviewed. Upon review, you may be contacted if further information is needed.
- Once your police report has been approved, a PBSO case number will be issued and an unofficial report will be emailed to you.
- Should you need an official copy of your report, please contact PBSO Central Records at 561-688-3140.
- If your report is rejected. You will receive email notification with a reason for the rejection.






