Prepares legal documentation and reports, processes fingerprints and pictures to ensure inmate identification, executes emergency plans, resolves disputes and performs necessary restraint techniques.

- Able to perform the essential functions of the job for which applying with or without reasonable accommodation.

- Possess a valid Driver's License
- Must present proof of automobile insurance upon offer of employment, free from "at fault" accidents or convictions for violation(s) of traffic law to include adjudication withheld for the past twelve (12) months. A good driving record will include no Driver's License suspensions in the past three (3) years.

SPECIAL REQUIREMENTS: Corrections Department employees are required to work overtime, with and without notice, and must be available for emergency call-in overtime.

The appeal process is the only method to appeal these matters and is available to internal PBSO applicants exclusively.
